

ORDINANCE NO. 33-82

AN ORDINANCE ADOPTING A CODE OF ORDINANCES FOR THE CITY OF ANDERSON, INDIANA, REVISING, REARRANGING, RESTATING, AMENDING, CODIFYING AND COMPILING THE EXISTING ORDINANCES OF THE CITY OF ANDERSON

WHEREAS, the 1981 General Assembly of the State of Indiana adopted Public Law 17 pursuant to I.C. 36-1-5-3 empowering and authorizing the legislative body of every town and city to codify, revise, rearrange or compile the ordinances of the unit into a complete, simplified code excluding formal parts of said ordinances, and

WHEREAS, the present ordinances of the City of Anderson were codified, amended and restated in December of 1963 and said code of ordinances was supplemented thereto and codified in October, 1971, and

WHEREAS, the Common Council of the City of Anderson has authorized the revision, rearrangement, restatement and amendment thereto of the existing ordinances of the City of Anderson into book form and the publication thereof to be known as "City of Anderson, Indiana, Code of Ordinances";

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Anderson, Indiana, as follows:

SECTION I: The ordinances of the City of Anderson, Indiana as heretofore adopted by the Common Council of the City of Anderson, are herein revised, rearranged, restated, amended, codified and compiled in book form and readopted and shall constitute the "City of Anderson, Indiana, Code of Ordinances", a copy of which is attached hereto, the same being incorporated herein by reference as if set out at length and identified as the "Official Copy of the City of Anderson, Indiana, Code of Ordinances", is hereby ratified, confirmed and approved in all respects.

SECTION II: The official copy of the Code of Ordinances shall be filed with the Office of City Clerk for the City of Anderson.

SECTION III: A copy of said Code of Ordinances be made available for public inspection during normal business hours in the Office of the City Clerk of Anderson for public use.

SECTION IV: All prior ordinances adopted by this Common Council shall be titled by chapter and section within the Code of Ordinances from and after the effective date of said Code.

SECTION V: The recodification of the ordinances for the City of Anderson shall not effect any offense committed or penalty incurred or any rights established prior to the effective date of said Code, nor shall such recodification affect the provisions of ordinances appropriating money, annexing or detaching territory, establishing franchises or granting special rights to certain persons, authorizing public improvements, authorizing the issuance of bonds or borrowing of money, authorizing the purchase or sale of real or personal property, granting or accepting easements, plats or dedication of land to public use, naming or vacating or setting the boundaries of streets, alleys or other public places, nor to any other ordinance of a temporary or special nature or pertaining to subjects contained therein.

SECTION VII: Said Code shall be deemed published as of the day of its adoption and approval by the Mayor and filed with the City Clerk of the City of Anderson.

SECTION VIII: The City Clerk of the City of Anderson shall publish a copy of this ordinance in two newspapers of general circulation within the City of Anderson and said Code shall be in full force and effect from the date of the publication of this ordinance and the copy of the Code of Ordinances identified as "Official Copy" of the same is filed in the Office of the City Clerk.
