

## **PUBLIC NOTICE**

### **Substantial Amendment to the FY 2021 Annual Action Plan Home-American Rescue Plan (HOME-ARP)**

**City of Anderson, Indiana  
Community Development Department**

The City of Anderson (“City”) will be submitting a Substantial Amendment for the 2021 Annual Action Plan to the U.S, Department of Housing and Urban Development (HUD). The Amendment consist of changes to the HOME Investment Partnership Program (HOME) Grant to include the HOME-ARP Allocation Plan. The City of Anderson was awarded \$1,372,583 in HOME-ARP funds in a one-time allocation from HUD to Qualifying Populations in the City of Anderson.

In accordance with federal requirements outlined in Notice: CPD 21-10 notice is hereby given to citizens and stakeholders of the City of Anderson that a draft version of the HOME-ARP Allocation Plan is available for review and a 15-day public comment period will commence.

**Public Review and Comment Period for HOME-ARP Allocation Plan:  
Monday, March 13, 2023 through Monday, March 27, 2023**

The Allocation Plan is required by HUD for the City to received federal HOME-ARP grant funds. The HOME-ARP Allocation Plan is a strategic plan detailing the allocation of funding to assist individuals or households who are experiencing homelessness, at risk of homelessness, fleeing or attempting to flee, domestic violence, dating violence, sexual assault, stalking, or human trafficking, and other vulnerable populations as defined by HOME ARP to reduce homelessness and increase housing stability. Allowable activities include affordable rental housing, rental assistance, supportive services, and/or non-congregate shelter. The Allocation Plan defines the City’s proposed use of federal HOME-ARP grant funds to address these needs.

#### **Public Hearing**

The public hearing will be to discuss the draft allocation plan of HOME-ARP funds to reduce homelessness and increase housing stability in the City.
